-All municipal streets including those subject to Permit part 2.3.7.a.iii.(c)) were swept twice during the Year 16 reporting period (once in May-June 2018 and May-June 2019).

-The Town has not completed outfall and interconnection prioritization but anticipates contracting with a consultant for completion in Fall 2019.

-The Town is considering options for an employee training program to begin in Fall of 2020.

-Town Official attended Southeastern Regional Services Group SWMP Workshop on June 6, 2019.

-The permit does not require tracking of existing BMPs for municipalities for discharges to water quality limited waterbodies and their tributaries where phosphorus is the cause of the impairment (Appendix H, part II.I.c.iii.).
